

**TERMS AND CONDITIONS OF THE PROMOTION**  
**"WE PLAY TO THE MAX**  
**WILSON 10-YEAR WARRANTY"**  
**Promotion extended until December 31, 2024**

**§ 1**

**Definition of the Organizer and the Service**

1. The promoter of the promotion is the producer, owner of the Wilson trademark and distributor of products under this trademark in Poland and abroad, Horn Distribution S.A., Kurantów 34, 02-873 Warsaw, entered in the register of entrepreneurs of the National Court Register kept by the 13th Commercial Division of the District Court in Warsaw, under the number 0000109020, NIP: 951184040. Warsaw under the number 0000109020, NIP: 9511828408, REGON: 012977688, share capital, fully paid-up PLN 1.121.125, hereinafter referred to as the "Organizer."
2. The Organizer has entrusted the provision of warranty and post-warranty service and the handling of complaints from purchasers of Wilson products to its own service organization, SERVICEU, 34 Kurantów Street, 02-873 Warsaw, hereinafter referred to as "Service."

**§ 2**

**Purpose of the Promotion**

1. The Organizer guarantees to users the high quality of its passive loudspeakers by offering a standard 2-year warranty period. This Promotion extends the warranty period to 10 years, which creates an additional argument facilitating the decision of choosing Wilson passive loudspeakers over other products available on the market.

**§ 3**

**Promotion rules**

1. The Promotion runs from November 1, 2020 to **December 31<sup>st</sup>, 2024**.
2. The Participant in the Promotion can be any person who during the period of the Promotion makes a purchase at an authorized store (traditional market store, chain store, or online store) of any of the products specified in the scope of the Promotion.
3. The participants of the Promotion may be only: natural persons of full legal age and full legal capacity who are consumers and who at the same time fulfil all other requirements for participation in the Promotion.
4. The only condition for participation in the Promotion, i.e. obtaining entitlement to free warranty protection, extended to a total of 10 years, is making a purchase of any Wilson passive loudspeakers between November 1<sup>st</sup>, 2020 and **December 31<sup>st</sup>, 2024**, which shall be confirmed by the date on the sales document and the warranty card received upon purchase, which are the only basis for claiming warranty rights.
5. Participation in the promotion is free and automatic, in the sense that anyone purchasing Wilson passive loudspeakers during the promotional period acquires rights to their 10-year warranty protection.
6. The organizer does not require product registration or other actions to participate in the promotion.
7. The promoter does not collect any personal information on its own behalf in order to sell products in this promotion.
8. The Promotion applies to all Wilson passive loudspeakers offered by the Organizer, purchased new, available at any authorized retailer, retail chain store or online retailer.
9. Active subwoofers with amplifier, cables, and other Wilson products are not eligible for the Promotion.

**Warranty Policy**

1. The terms of the warranty are set forth in the warranty card accompanying the product and on the Organizer's website at [www.horn.eu](http://www.horn.eu), under the "Service" tab.
2. In each case of the warranty application, the Service first verifies the date of purchase of the product and determines whether the application qualifies for the standard 2-year warranty protection or the extended promotional period according to these rules.
3. The time period shall not include the time for repair, replacement of the product or services performed under the warranty, guarantee or non-conformity of goods.
